It's a great way to stay informed and engaged with your super, and we're here to make it as easy as possible.



Industrial body payments

Industrial bodies are defined in legislation as organisations registered under the Fair Work (Registered Organisations) Act 2009 (Cth). Payments to industrial bodies includes partnership arrangements – which may include advertising, marketing and education services.

Oasis Fund Management Limited does not make payments to Industrial bodies.

Related party payments

Related party payments occur when payments are made by the super fund to a connected entity of the trustee of the Fund which provides services to us.

Payments include - investment management costs, promotional and marketing services, payments to key management personnel (including the trustee or executive of the trustee of the Fund), Board committee fees, insurance services, financial planning, arrears collection and other member services.
